

# Subscription Rates 2007-2008

*Before submitting your application please study the following information.*

## Re-assessment:

Please note that ALL MEMBERS are re-assessed within a five year period, or sooner, if appropriate.

## Code of Practice:

All members are required to adopt the AMUSF Code of Practice.

## Insurance:

Members must have adequate business insurance including public liability insurance which is mandatory.

## Application Fee:

The application fee of £50.00 plus VAT. Acceptance of an application does not guarantee membership. **Application fees are NOT REFUNDABLE if the application does not proceed for any reason.**

## Overseas applications - VAT:

VAT\* is payable on overseas subscriptions within the EC, this is in addition to the subscription; postage will be charged at air mail rates for Group publications which is based on the Royal Mail rate per destination.

## Publications:

The Group's publications are included as part of the membership

subscription and this forms part of the non VAT element of the subscription rate. Therefore the VAT is calculated on the NET amount less the non -VAT element of £35.00 which covers publications and insurance services. (The publications are not an optional add on, but an integral part of the package.)

## Payment Surcharges and Payment of Subscriptions:

Payment is acceptable by Mastercard, Visa, Delta, (Switch) Maestro or Cheque. Surcharge £10.00 for credit cards no surcharge for debit cards.

## Payment Method:

Subscriptions are payable by one of the above methods, but in addition you may pay by Direct Debit (Please ask for details) The direct debiting group member is a registered credit broker.

## Acceptance - Important:

It is assumed you will wish to take up membership if you meet the criteria. Therefore, If your membership application is approved, you will be invoiced for the current period. If you do not require membership you must let us know as soon as you receive the invoice and confirmation letter. Failure to do so may render you liable for the current fees.

## Resignation:

ALL members are obliged to advise the Association IN WRITING before the end of their subscription year if they do not wish to renew. Failure to give notice at the required time will render the member liable for a further year's subscription. This requirement is unaffected by the date at which the membership renewal notice is received.
